

# Introducing the Future Proof blog

The Future Proof blog is one of State Records' primary communication tools about digital recordkeeping issues. The digital business environment changes rapidly, and the blog enables State Records to quickly provide advice and disseminate information about digital recordkeeping issues.

The Future Proof blog also allows us to obtain information from the NSW public sector. We use the blog to seek feedback on the advice we provide, to ask questions and to issue surveys on recordkeeping issues significant to the NSW public sector. The information we receive through these consultation mechanisms is fed back into our business processes and informs all the work that we do.

Over time, the blog has become a centralised information resource on a range of recordkeeping issues relevant to the NSW public sector, and to digital recordkeeping more broadly.

It is also the main portal for the dissemination of information about the design and development of State Records' innovative Digital Archive facility. The project team building our Digital Archive are world leaders in their field and they use the blog to regularly post updates about their work.

#### Where do the navigation buttons take me?

There are navigation buttons at the top of the blog:

- The Home page includes our most recent posts. If you simply want to browse you
  can scroll through these and use the 'Older entries' button at the top to view
  previous pages.
- The About page describes the Future Proof strategy and the purpose of the blog.
- The **Resources** page is a bridge between the blog and State Records' website. It includes a list of 'hot topics' that are currently popular on the blog. The Hot topics then link to relevant resources on State Records' website and to blog posts about these issues. Current hot topics include compliance with the *Standard on digital recordkeeping*, cloud computing, raising awareness of digital recordkeeping challenges, electronic records and document management systems, digitisation, social media and SharePoint. The Resources page also features links to our two page Future Proof flyers.
- The **Digital Archive** page describes the work being undertaken by the project team building our digital archiving solution for the whole of the NSW government.
- The Podcasts page links to the Future Proof podcast series. Podcasts on various recordkeeping themes are added regularly.
- The Contact page enables you to send an email to the Future Proof team
- The Sitemap page links to all pages and posts (by category).

## How can I browse by category?

You can browse by category using the Sitemap navigation button.

You can also browse the blog by choosing one of the categories listed to the right of each post and clicking on it. The categories are currently:
